Thank you for your interest in studying at the Australian Centre of Further Education.

The purpose of the GTE form is to enable ACFE to make an assessment of the genuineness of an applicant's intention to complete their studies. Each question is targeting a specific area that ACFE will base its assessment on, and the Department of Home Affairs may be interested in during your visa application.

The GTE requirement provides a useful way to help identify those applicants who are using the student visa program for motives other than gaining a quality education.

Your individual circumstances must demonstrate that you genuinely intend to stay in Australia temporarily.

The factors that are considered during assessment of the genuine temporary entrant (GTE) requirement include:

- Your personal circumstances in your home country;
- Your potential circumstances in Australia;
- The value of the course to your future;
- Your immigration history;
- Any other matter that is relevant to your intention to remain in Australia temporarily.

To facilitate our assessment, please complete and return this form to your respective ACFE Admissions Consultant. ACFE must be satisfied that you are a genuine student before giving you an offer.

- I have read, understood and consent to the Fees & Refund policy and procedures as outlined in the Course Handbook.
- I understand that my visa may be rejected or cancelled by Department of Home Affairs if it is determined that documents supporting my application are fraudulent or I have made false declaration.
- I understand that my visa application will be rejected if Home Affairs is not satisfied with me being a genuine student, and I understand that my visa may be cancelled if I do not abide by the conditions of my visa.
- I understand that I will be required to update any changes to my personal details direct to ACFE within 7 days of my arrival in Australia.
- I fully understand that if I request a transfer to another provider (release letter) within the first 6 months of study, ACFE may refuse my request.
- I fully understand that if I decide to downgrade (i.e. go to a course that has a lower AQF level), I will not be released from ACFE and I will be required to apply for another visa.
- I confirm that my agent has not completed this form on my behalf.
- I understand that if I defer, ACFE cannot guarantee that all courses will be available for the requested intake.
- I confirm that by completing this application I am giving written consent to ACFE to verify the information supplied by me in this form and request further documents as required.
